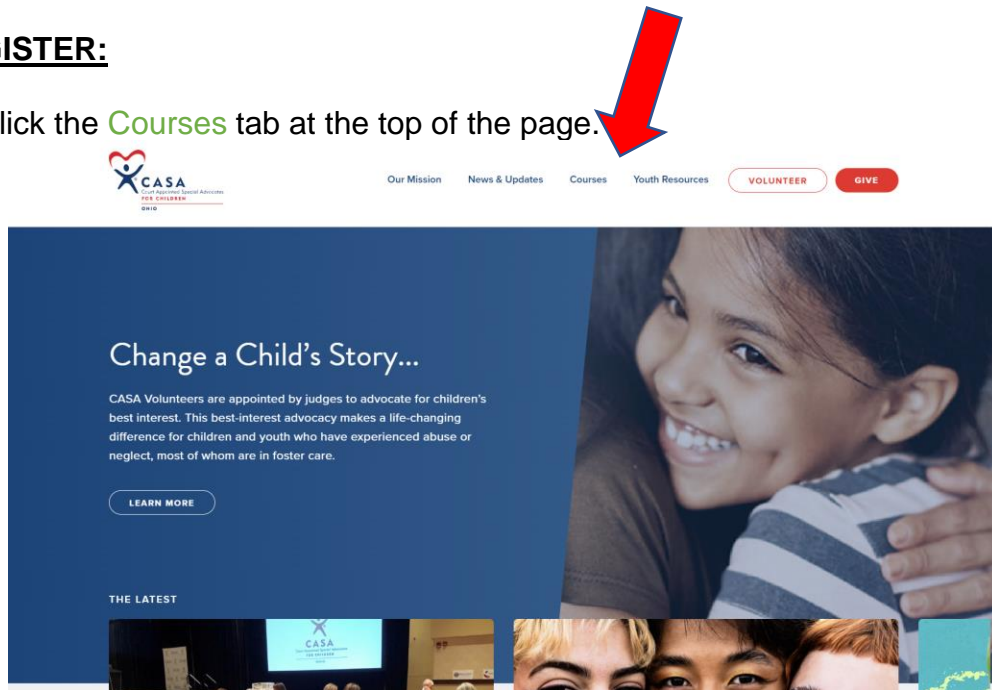


Ohio CASA's On-line Volunteer Education Instructions

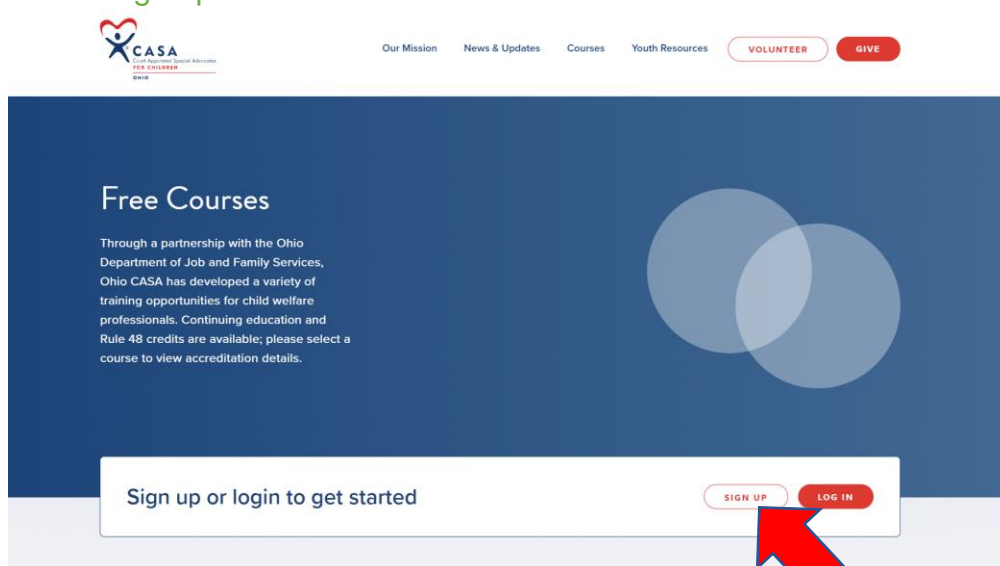
To get access to Ohio CASA's on-line education courses, you must first register on the Ohio CASA's website. The following instructions will walk you through both the registration process and enrolling in a course.

TO REGISTER:


1. Click the **Courses** tab at the top of the page.

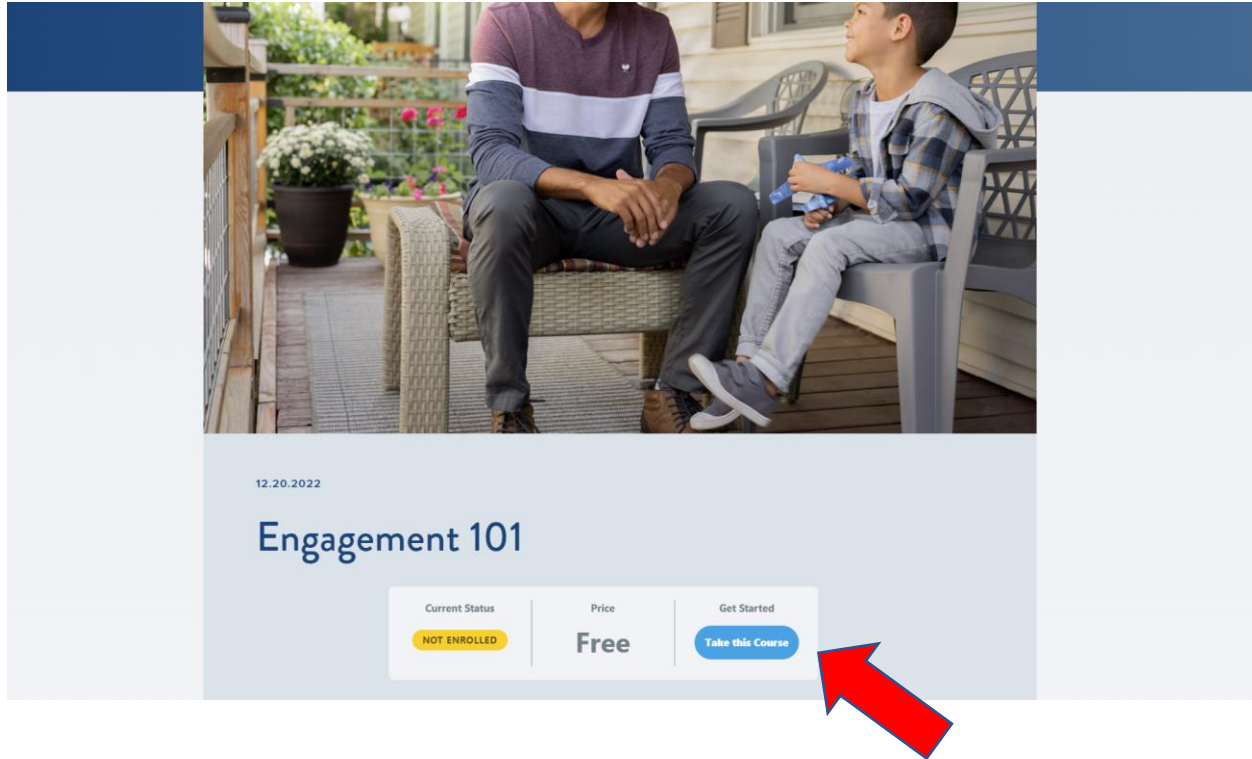
2. Enter email address and password and click on sign in



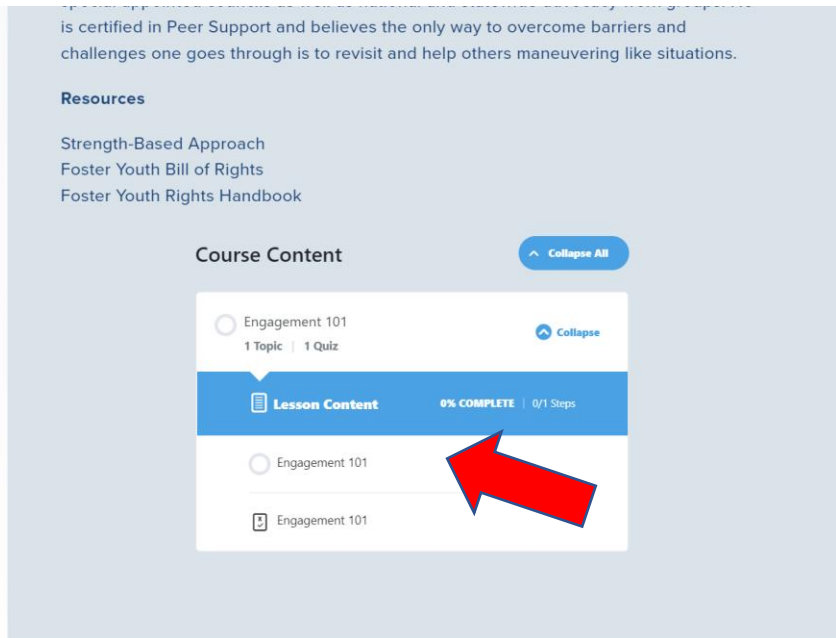
3. Pick course of your choice and click learn more.

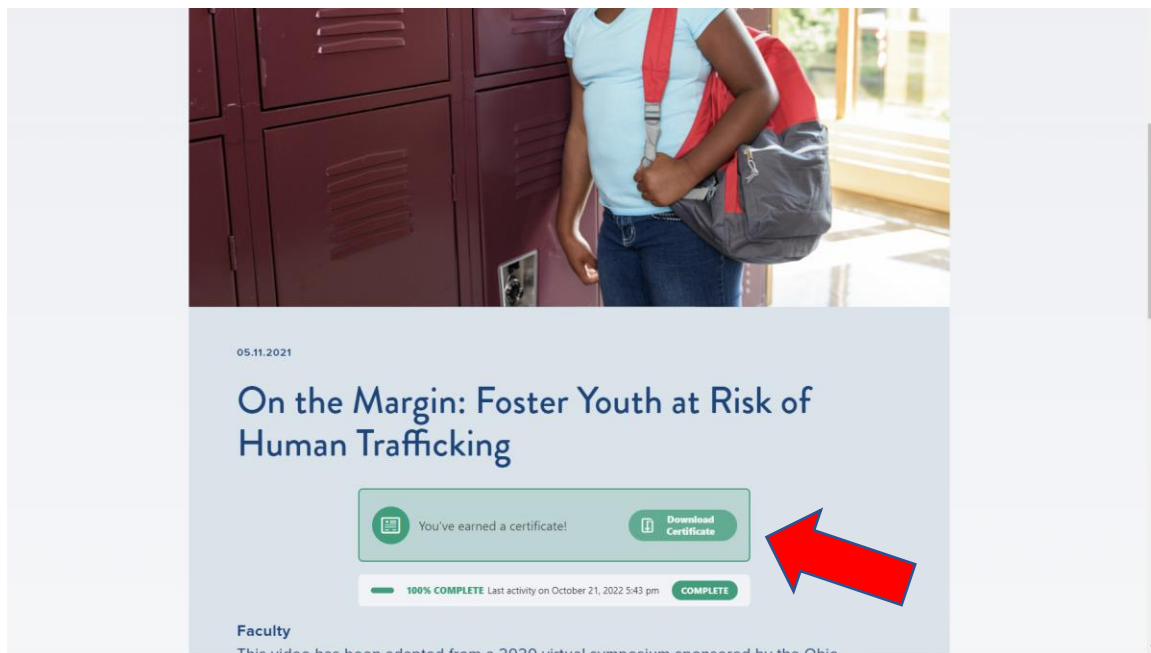
