Charlie Appelstein, MSW, *Appelstein Training Resources*

Charlie Appelstein, MSW, is a prominent youth care training specialist and author who trains and consults with parents and professionals throughout the U.S. and internationally. Charlie has authored two books that are widely used within the field, including *No Such Thing as a Bad Kid – Understanding and Responding to Kids with Emotional & Behavioral Challenges Using a Positive, Strength-Based Approach*. Charlie delivers a message of hope and possibility to our most vulnerable children and those who guide them. He lives in New Hampshire with his wife and daughter.

Eileen P. Anderson, EdD, *Anne Templeton Zimmerman, MD Professor of Bioethics; Director, Educational Programs in Bioethics and Medical Humanities; Director, Center for Medicine, Society and Culture, School of Medicine, Case Western Reserve University*

Dr. Eileen Anderson is the Anne Templeton Zimmerman, MD Professor of Bioethics at the Case Western Reserve School of Medicine, where she directs the university's educational programs in Bioethics and Medical Humanities. An award-winning teacher, mentor, and researcher in the area of child and adolescent wellbeing, she is the founding director of the Center for Medicine, Society and Culture. A native Cleveland, Dr. Anderson earned her doctoral and master's degrees at Harvard University in Human Development, Psychology, and Anthropology after attending Brown University. She completed postdoctoral fellowships in Interdisciplinary Studies of Culture, Development, and Neuroscience at UCLA before joining the Departments of Anthropology and Bioethics at CWRU. She has spent the past two decades investigating how children and adolescents adapt to changes in their environments in ways that both advance and harm their health and is currently conducting research on child wellbeing in the U.S. Guardian ad Litem system. Dr. Anderson is widely published, regularly appears in the media, and has earned grants from NSF, NIH, the Office of Research Integrity at the U.S. Department of Health and Human Services, the National Academy of Education, and the Spencer Foundation, among others. She is the creator of the Kids' Health and the Courts podcast.

Yonnae Asé, *President, Hamilton County Youth Advisory Board*

Yonnae Asé is a 25-year-old African American Queen, licensed cosmetologist, certified peer support specialist, and proud former foster youth. She serves as President of the Hamilton County Youth Advisory Board, using her voice to advocate for system-involved youth and real policy change. She is currently interning with Cincinnati Works, iFoster, and TAY AmeriCorps as a Peer Support Navigator, connecting youth to the resources they need to thrive. From beauty to behavioral health, she shows up as her full self—bold, compassionate, and purpose-driven. She doesn't just talk about change; she is the change. Be a voice, not an echo—because every lived experience deserves to progress!

Captain Shawn Bain (Ret.), *Street Smart Ohio*

Shawn Bain began his career in law enforcement in 1985. Shawn has been assigned to many different areas within law enforcement, including the Jail Division, Patrol Division, Canine Unit,

Dr. Bethel serves as an independent trainer and consultant with the Ohio Child Welfare Training Program where he was recognized for his training excellence as a recipient of both the "Rising Star" award in 2007 and the "Linda Pope" award in 2014. In 2018, Dr. Bethel was awarded an Award of Excellence in Research from the Association for Play Therapy for his research on the use of play therapy for children with disabilities. Dr. Bethel is a frequent presenter at professional conferences and is recognized as an innovative, an exciting presenter on a local, state, national, and international level

Whitney J. Raglin Bignall, PhD, is the Associate Clinical Director and Leader of Community Impact and Evaluation at The Kids Mental Health Foundation. She is also an Assistant Professor of Pediatrics in the Division of Psychology and Neuropsychology at Nationwide Children's Hospital (NCH) and The Ohio State University College of Medicine. Clinically, she works as an integrated primary care psychologist at one of NCH's primary care centers, which serves a primarily low-income and racially diverse community. She also implements a program to help enhance parenting skills for raising young children and has built partnerships with community organizations, primary care offices, and neighborhood schools.

Dr. Kailey Bradley, PhD, LPCC-S, NCC, FT, *Refuge Counseling LLC*

Dr. Kailey Bradley, PhD, LPCC-S, NCC, FT, received her master's in clinical mental health counseling in 2015 from Ashland University and her PhD in counselor education and supervision from Ohio University in 2024. Dr. Bradley spent five years as a pediatric hospice bereavement

coordinator before opening Refuge Counseling and going back to school in 2021. Currently, she is the co-owner of Refuge Counseling LLC and is an adjunct professor of thanatology at Marian University and an adjunct professor of counseling at Marshall University, where she teaches a wide range of courses including: Crisis Counseling, Grief Counseling, Intro to Death and Dying, Pediatric Hospice Care, Childhood Bereavement, Grief Theory, Disenfranchised Grief, and Expressive Arts in Counseling. Dr. Bradley also has nine peer-reviewed publications (currently) on topics related to bereavement and counseling, and she is the current president of the Association for Child and Adolescent Counseling, Ohio Division.

Jaleshia (Jay) Brown, *Founder and Coordinator, Hamilton County Youth Advisory Board*

Jaleshia (Jay) Brown spent 11 years in foster care and aged out of the system. She obtained a Bachelor of Science degree in Criminal Justice and a certification in violence prevention while working as an STNA to support her and her son. Determined to create a better life for her son and a simpler future for others, she began her career interning with the Hamilton County Juvenile Court, moving on to a role as a Deputy with the Hamilton County Sheriff's Office. After learning her passion was elsewhere, her journey led her to case management of individuals experiencing homelessness. She helped them identify and remove barriers to stabilized housing and gave them the resources and support to sustain it. For the last three years, she has been running the Hamilton County Youth Advisory Board, a state-funded advocacy group for current and former foster youth aiming to improve the foster care system, influence policy change, and create brighter futures for foster youth.

Sarah Buffie, MSW, LSW, is the founding director of Soul Bird Consulting and a nationally recognized Trauma-Responsive Care trainer. Sarah's academic focus on Polyvagal Theory, Positive Psychology, and Trauma-Sensitive Mindfulness informs her holistic approach to trauma work. Her service in AmeriCorps and the Peace Corps shaped her belief in the power of interdependence and community connection. As a certified Laughter Yoga Instructor, SAH Method practitioner, and graduate of the Polyvagal Certificate Course, she integrates body-based practices into her work. Sarah's mission is to guide families, educators, and helping professionals toward regulation, resilience, and restoration—one nervous system at a time.

Jason B. Bunting has a Master of Social Work degree and LSW from The Ohio State University and a Level 2 Trauma-Informed Care Certification from the Tristate Trauma Network. Combined, Jason

has been involved in leadership, supervision, and training for 24 years. Currently, he is the Trauma-Informed Care Administrator for the Ohio Department of Developmental Disabilities (DODD), responsible for the overall program administration and implementation of Trauma-Informed Care within DODD's Developmental Centers. Previously, he was the Superintendent of the Northwest Ohio Developmental Center (NODC/Toledo, Ohio) within DODD. Prior to his employment with DODD, he spent over 19 years of his career with the Ohio Department of Rehabilitation and Correction (ODR&C). During that time, he was employed at the Marion Correctional Institution (MCI/Marion, Ohio) and held a multitude of positions ranging from a Social Worker to the Warden of the facility. The highlight of his experiences was his participation in a leadership panel for Bryan Stevenson, the founder and Executive Director of the Equal Justice Initiative. The Founder of the "Elizabeth Smart Foundation," Elizabeth has also helped promote The National AMBER Alert, The Adam Walsh Child Protection & Safety Act, and other safety legislation to help prevent abductions. Elizabeth has chronicled her experiences in the New York Times best-selling book, "My Story." In addition, she and other abduction survivors worked with the Department of Justice to create a survivor's guide, entitled, "You're Not Alone: The Journey from Abduction to Empowerment." Elizabeth has recently released a new powerful and inspiring book about what it takes to overcome trauma, find the strength to move on, and reclaim one's life. "Where There's Hope" is the result of Elizabeth's mission: It is both an up-close-and-personal glimpse into her healing process and a heartfelt how-to guide for readers to make peace with the past and embrace the future. Elizabeth's abduction and recovery continue to motivate parents, law enforcement and leaders worldwide to focus on children's safety. She emphasizes vigilance by "everyday" people and the belief that hope always exists to find every missing child. Smart attended Brigham Young University, studying music as a harp performance major. She married her husband Matthew in 2012, and they now have three beautiful children. Elizabeth's example is a daily demonstration that there really is life after tragedy.

Valeda Smith, *Training Coordinator, The Center for Family Safety and Healing*

Valeda Smith is a Training Coordinator with over 10 years of experience working with youth and families. She is a graduate of Wittenberg University with a major in Sociology. Currently, she
